Jovan Stevovic, CEO and Co-founder of Chino and a globetrotter. Jovan, thank you for taking the time to talk to me.

1) Where are you from and where do you live?

Complex question. Originally from Serbia, I grew up in Rovereto, a beautiful town of the very northern Trentino region in Italy, where I studied and started my career. Currently most of my time I'm in Berlin and Italy.

2) What was your journey to becoming a lawyer?

Well actually I'm a PhD in Computer Science. I became an expert in data protection, privacy and security while working in healthcare field and doing research and innovation projects in Trentino and US at HP Labs in California. I got passionate so much that I started creating my own ideas for start-ups, and one of those was awarded in 2014 at the Idea Challenge from EIT Digital. The project was presented by myself together with my friend and colleague Stefano Tranquillini. We quit our jobs and started working on Chino.io, and here we are today, almost 20 people team working with most innovative institutions and start-ups across Europe and abroad.

It was an amazing experience that taught me many lessons, such as how to manage stress and deal with pressure in chaotic and complex situations. Those lessons are helping me in daily life nowadays, where I need to lead a small company.

With mine (and my co-founder's) expertise we are able to help companies to build innovative data driven products and ensure privacy and regulatory compliance. This requires tech foundations and legal knowledge.



4) What are your hobbies?

Traveling definitely. I started very young due to necessity, but now it's a passion and virtue. I have 3 main homes, and many others in Europe and abroad.

Ethics Board has been established

The Ethics Board (EB) of the RES-Q+ project was established, consisting of three members, prof. Anne Gerdes (Denmark), Dr. Mary Joan MacLeod (UK) and Mgr. Radek Halouzka (Czechia), nominated by General Assembly members. EB will address issues related to the involvement of patients in research activities, the protection of personal data and the use of AI in healthcare. The EB will provide inputs to project strategy, compile annual Ethics Reports as part of the ethics deliverables in WP10 and contribute to T2.3 Investigating relevant legal and ethical aspects in Work Package 2. It will receive periodic updates about the project results and participate in the annual meetings of the RES-Q+ consortium.

Deliverable submitted

The ethics deliverable 10.1 OEI - Requirement No. 9: Ethics Advisory Board set up and CVs was successfully submitted March 31 as a part of WP10. You can find final version of this document on shared <u>Google Drive</u>.

Deliverables in progress

We are working on 3 deliverables to be submitted at the end of April: the 1st version of the Plan for Dissemination and Communication Activities (D8.3), the 1st version of the IPR Management Plan (D8.4) and the 1st version of Data Management Plan (D9.9). All these documents are considered as the first versions and will be updated during the lifetime of the project.
